### The Great Gravel Pack-In is coming on

March 29th. It's in the Middle Waddell this year and folks are being asked to park on the Tacoma Trail Cruisers property (128th out of Littlerock to Waddell Creek Road. At the intersection of Waddell Creek and Sherman Valley roads turn left and drive another 1/2 mile. The property is on the left.) Meet in the Middle Waddell Campground at 9:00 am for a safety meeting before heading out. Lunch is provided. Bring work gloves, water and raingear.

### The Supreme Court made their decision

known regarding rail-trails. That decision will impact an unknown number of trails. Existing rail-trails or trail projects ARE NOT affected by this decision if ANY of the following conditions are met:

- The rail corridor is "railbanked."
- The rail corridor was originally acquired by the railroad by a federally granted right-of-way (FGROW) through federal lands before 1875.
- The railroad originally acquired the corridor from a private land owner.
- The trail manager owns the land adjacent to the rail corridor.
- The trail manager owns full title (fee simple) to the corridor.
- The railroad corridor falls within the original 13 colonies.

Railbanked trails in the state are:

- Ferry County Rail Trail
- Klickitat Rail Trail
- Cascade Rail trail from Hamilton to

Concrete (half it's length)

- East Lake Sammamish Trail
- Sammamish River Trail
- Lake Washington Trail
- Lacey Woodland Trail
- BNSF Railway, South Aberdeen (not yet a trail)
- Naches Branch Line (not fully completed, Naches has paved a mile so far headed towards Yakima)
- Bill Chipman Palouse Trail (Pullman to Moscow ID)
- short segment of the Foothills Trail (136th Street Court E to Puyallup River)
- short segment of the Ship Canal Trail (W Ewing Place to a point 0.17 miles southeast along W Ewing Street, east of the Ballard Locks, Seattle)

**We have some work parties other than the Great Gravel Pack-In coming up in April.** Before the Capitol Forest opens to horses on May 1st, we need to conduct a cleanup at Mima Campground (our adopted campground). Our adopted trail also needs clearing.

The campground party will be on April 12th, 9 am at Mima Campground. Bring shovels and rakes. We will do the trail work on April 19th, 9 am at Mima Campground. Bring loppers and shovels. April 26th is reserved in case either of the previous two dates gets rained out.

**Chapter rides:** No Capitol Riders member went on the March 9th ride at JBLM training area 8. A ride at training area 10 (near area 8) is coming up on April 13. ## **Capitol Riders of BCHW Meeting Minutes**

### **Littlerock Fire hall**

#### **March 4, 2014**

President Norman Green called the meeting to order at 7:03 pm.

Twelve people were in attendance with no guests.

The February 2014 meeting minutes were approved.

#### **Treasurer's Report – Deborah Green**

The chapter is solvent. There is nothing outstanding. We have four new membership renewals. Deb asked that she be kept in the loop regarding renewals and membership.

Chris Enrico had nothing new to report on the newsletter.

Chris Enrico said that he has been working on the BCHW volunteer miles database.

Chris Enrico stated that he was not aware of any decision regarding the rails to trails decision before the Supreme Court. A discussion about the trails and it's going before the court ensued.

#### **Directors Report – Karen Johnson**

Karen mentioned the Haney Meadow road project and that the road needs work after the Table Mountain fire in 2012. The BCHW is taking on the road as a project. Traildusters chapter has \$5,000 for the road repair. They are meeting on 3/5 to make a decision and are asking other chapters to donate. Total cost would be \$8,000. A motion to donate with a second. Discussion resulted in a clause to "determine the need and financial capability of the chapter." One "nay". Passed.

Karen mentioned the "Big Tent Coalition". It is an attempt to generate the interest of legislators so they support us with funding. The equestrian community has a big impact on the local economy since we support Veterinarians, farriers, feed stores and hay ranches, riding areas, horse trainers and more.

Karen reminded the group that Rendezvous is coming.

Karen mentioned the Great Gravel Pack-In on March 29th. They are looking for volunteers to bring cookies for lunch. We need 4 to 6 dozen cookies from each chapter. We need the cookies by 3/28.

#### **Work Parties – Norman Green**

Norm said he had talked to Nick Cronquist who has granted permission to ride the trails for the purpose of determining what trail

work is needed and where. We will have a work party on April 12th. Karen said we need to have one at Mima Campground as well before the forest opens.

Traci Koch mentioned an April 6th saw certification at Griffenwood. Contact Lori Lennox.

Chris Enrico asked how many miles of trail the chapter has to maintain. The answer was 9.5 miles.

Dean Hartman said that April 19th and 26th are the last two Saturdays before Capitol Forest opens. With the subsequent discussion it was decided that we will have the campground work party on April 12th and the trails work party on April 19th. That leaves April 26th as a backup if we need it. Meet at 9 am at Mima Campground for both work parties.

Hoofprints – Peggy Tucker not in attendance.

Chapter Rides – Carrie Russell

Carrie said that there has been a change in dates. The March 8th ride at JBLM training area 8 had to be moved to the 9th. April 12th at training area 10 is now on the 13th.

Clothing – Dean Hartman showed his Capitol Riders jacket. Norman asked how many were interested. Sue Koch will take the lead on determining costs and options. We may still have the graphics image on file with the supplier, saving us the cost of set-up.

Norman asked the group for photos to post on the web site. Mickie Hatrup volunteered an article for the newsletter. She also asked about getting a guest speaker – Rainier Therapeutic.

Norman mentioned the LNT class at Sahara Horse Camp (April 5-6).

Norman also motioned that there is Treasurer training at Rendezvous.

Bylaws –

Traci Koch told the group that Darrell Wallace had said to move the part about the Director to the Standing Rules.

A motion to pay the Treasurer's gas and room for training at Rendezvous was made and approved. (BCHW made it a requirement they attend)

## **GUEST OPINION COLUMN** — We deserve better from Olympic National Park's Wilderness Stewardship Plan

OLYMPIC NATIONAL PARK currently is conducting a series of public meetings in communities around the park and in Seattle seeking public comment on the preliminary draft alternatives for ONP's Wilderness Stewardship Plan.

This is important because it is well understood that ONP is the No. 1 reason tourists come to the Olympic Peninsula.

I suspect local festivals come in second, but collectively, they are dwarfed by the millions who come here to see the park.

Policies adopted in this planning process will strongly influence the trends in numbers of visitors to ONP and to the communities on the Olympic Peninsula.

Tourism is an important part of a diverse economy on the Olympic Peninsula.

Recent stories in the Peninsula Daily News note that nearly \$1 million per year is dedicated to enhancing tourism in Clallam County.

This is just the public tax money.

It does not include additional sums of private money spent to promote tourism here.

Yet frustration remains over the lack of growth in this economic sector.

Witness the questions being raised by local business groups in the Port Angeles area as they explore ways to focus the scattered efforts of hundreds of volunteers carrying out overlapping missions in multiple organizations.

They ask: “Why can’t we get better results from this public spending?”

The preliminary draft alternatives offered by ONP are bad news for those working to enhance tourism on the Olympic Peninsula.

They offer nothing but the false choice between encouraging visitors to the park and saving the wilderness from the influence of mankind.

The four alternatives provided include Option A — the “no change” alternative, which, according to public statements by park representatives, they do not intend to adopt.

Three additional alternatives (B through D) are each progressively designed to reduce the number of people who can access the park and its wilderness zones.

While the vast majority of park visitors never visit the designated wilderness areas, the anti-human policies embedded in these alternatives will certainly send the message that people are not welcome.

A pushback of human influence from wilderness areas will reduce opportunities for people to enjoy wilderness or near-wilderness experiences.

Ultimately, the very essence of the Olympic National Park experience will be shielded from visitors, and tourist numbers will decline.

We deserve better.

It does not have to be this way.

Why not adopt a policy with twin objectives: maintain park wilderness and increase the number of opportunities for people to visit and experience the park?

If this were an alternative and adopted, the park managers could devise strategies to accommodate more park visitors while protecting the very reason people from all over the world come to the Olympic Peninsula.

Many national parks are dealing successfully with the apparent but false conflict between increased visitation and wilderness protection.

They include Zion, Grand Canyon and Denali national parks.

The preliminary draft alternatives provided for comment are based upon the philosophical value that sees humans as incompatible with natural areas — that is, exclude humans for its own sake, not associated with impacts to ecological function, external human influences such as climate change or impacts to scenic beauty.

Not all Americans share this value.

Some believe that it is impossible to “protect” areas from any human influence, direct or indirect, and that the value of human interaction with undeveloped lands is an important opportunity that should not be abridged in our public parks.

National parks are a treasure of all Americans for all Americans — not just for those who claim moral rectitude of a certain philosophical value.

One cannot escape the irony of Clallam County civic organizations seeking desperately to increase the effectiveness of tourism promotional efforts, while at the same time the Olympic National Park quietly moves through the motions of collecting public comment on carefully crafted management alternatives destined to reduce numbers of visitors to our communities.

**Wilcox Ride** - Michael Mahaffey reported that the annual Wilcox Ride to benefit BCHW is scheduled for August 16-17, 2014.

**Legislative** - Jeff Chapman

Report was posted.

**Rendezvous** - Lori Lennox and Jason Ridlon

Rendezvous is bigger than last year - more campers, more vendors, etc. There will not be a band - instead there will be musical entertainment by Stan Kvistad and Tearney Ford.

Puppy Dog? Not!

## Did you know PROPANE TANKS do expire?

Don't show up trying to refill a half empty propane tank that has expired. Especially don't get caught up in this when on the road or filling fuel for an outing. When tanks are close to expiring make sure to completely use up all the fuel first. Then simply take it in for an exchange on a full one. Most exchanges on a small 5 gal or 20lb BBQ size tank, one that is also full, costs right around \$20, nearly what it costs to refill a completely empty tank.



Propane tanks do expire. Federal law requires re-certification after 12 years from the original manufacture date. A coded date is stamped into the carrying handle of the tank. The tank expires at the end of the month of the date stamped. They will refuse to re-fill an expired tank. The first 2 digits represent the month. In this example 04 is April. The last 2 digits represent the year of manufacture, in this example 2002. This tank expires the end of April 2014.



Tanks can be tested and re-certified and will be good for another 5 years. The new date will be stamped or etched near the original date. Quite frankly it is easier to just exchange the BBQ size tank and be done with it rather than taking it somewhere and paying to have the tank re-certified, then having it refilled.

Tag the tank with a note once the year of expiration has been reached. That way you are reminded to completely use it up before you need a refill. Don't take these on the road or to outings where you might run out and need a refill. Sometimes exchange locations are nowhere nearby. Since any reputable fuel dealer will not fill an expired tank you might get caught up with no propane.

Another helpful stamped number you will find on the tank find tells you the empty tank weight. Find the TW followed by some numbers. Those numbers indicate the empty weight. In our example this is TW18. This tank empty is 18lbs. So since this is a 20lb tank (holds 20lb of propane) the actual full weight should be 38lbs (18+20=38). You can weigh your partially filled tank on a scale to get an approximate amount of fuel remaining. If the actual weight was 28lbs (28-18=10) you actually have 10 lbs of fuel left, or half a tank.
