



## Minutes from the meeting of January 13, 2009

President Ed Haefliger called the meeting to order at 7:10 PM.

### Minutes

The minutes of the November 11, 2008 meeting were approved as printed in the December Hoofbeats newsletter.

### Treasurer's Report

Lee Munroe gave the treasurer's report and commented our treasury funds are continuing to decline, therefore the club should think about a fundraising activity for 2009. She also reminded everyone that **dues are due by January 31 to ensure you will continue receiving the Hoofbeats newsletter. Members that have NOT paid dues by January 31 will be removed from the membership list.**

### Director's Report

The December BCHW Board of Directors report and the Public Land Manager's report were both published in the December Hoofbeats newsletter. Jeff explained that BCHW is seeking donations for a legal fund to help preserve riding privileges in the Hanford Reach area of Eastern Washington. He made a motion that Capitol Riders donate \$100.00 toward the BCHW Legal Fund. The motion passed.

Jeff also explained that Okanogan County purchased some property along highway 97 that will ensure easy access

to the Okanogan Wenatchee National Forest for recreation. The property will serve as a trailhead to the recreation area. There is an additional \$24,750 needed to help pay for the trailhead property. A motion to donate \$100.00 toward this purchase was withdrawn.

There will be an event at the Thurston County Fairgrounds called "Go Play Outside" sometime in May. Jeff will get further information on this and email members.

### Committee Reports

#### Trail Rides/Social events

There will be a planning meeting for 2009 trail rides and social events on Friday, January 23, 6:30 PM at the home of Karen and Ron Johnson. All members are invited to help brainstorm. Members are asked to bring a medium pizza of their choice for a pizza potluck. Directions to Johnson's home will be sent in an email.

#### Hoofprints

Jeff reminded everyone that January is the beginning of a new year for the Hoofprints program. #### Website

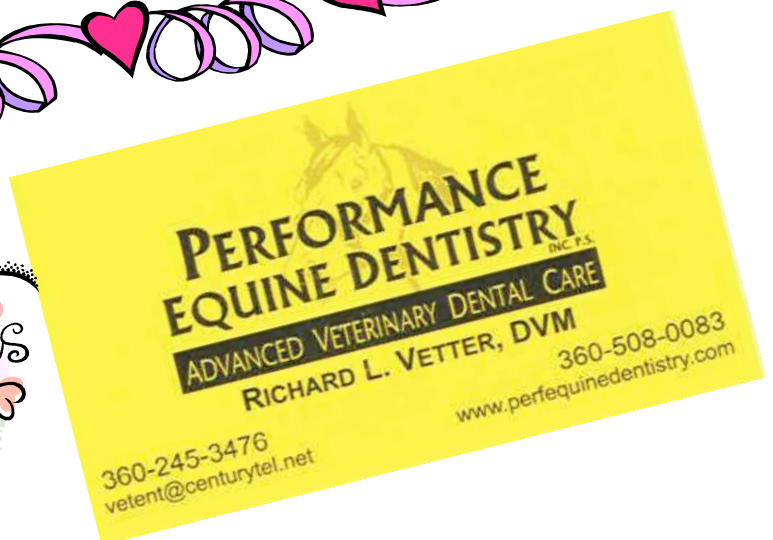
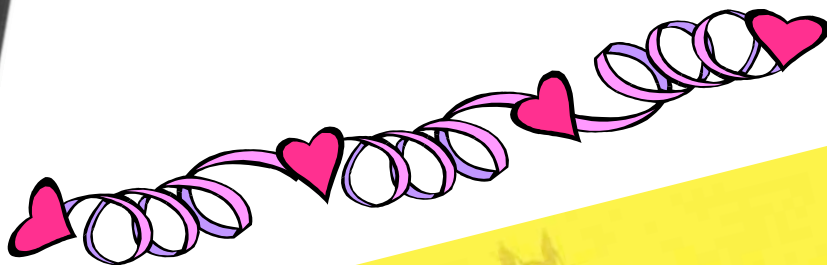
Dean Hartman said that he has extra Capitol Riders Map Books if anyone needs one.

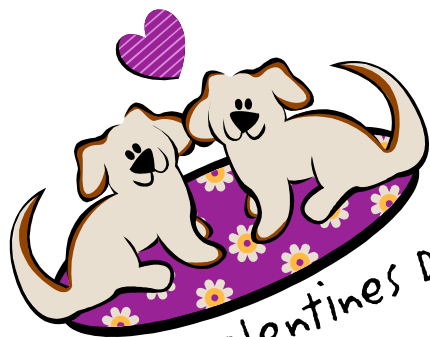
