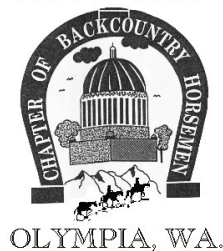

### Potluck Dinner at Barry and Carrie Russell's February 26th 6 pm

Here are the directions to Barry and Carrie's home:

- 1) Address is 841 101st Ave S.E. / 360-438-1873/ 6:00 February 26 Saturday
  - 2) Take Exit 99 Scott Lake/93rd. Turn east over freeway and go past the McDonalds truck stop. You are now on 93rd

LNT ? Just what is that? What does it stand for?

LNT or Leave No Trace are principles that all in the great outdoors should practice. “All” refers to hikers, bikers, equestrians, motorcycles and others. These principles teach that we need to respect the land by leaving little trace of our having been there. This is important since more and more pressure is being placed on the lands by multiple user types. And if we do not do what we can to impact as little as possible, sooner or later the land owner or land manager will lock us out.

This requires us to ride on established trails and not making your own. This can mean riding through a mudhole and not around it. It means packing out your garbage (and others if you come across it.) It means camping away from streams or lakes so as not to foul the water. It means not tying horses to trees such that they strip the lower branches.

Speaking of land managers - Capitol Riders works primarily with the state Department of Natural Resources but other chapters also work with the US Forest Service. We do a lot of trail maintenance for them since money is almost nonexistent. And if we did not, trails would get overgrown, full of fallen trees and otherwise become unusable to anyone, including horse riders. Some members run pack strings to help supply trail crews hired to maintain trails. Others may go for a ride and pick up garbage or cut out trees across the trail.

Primarily due to Backcountry Horsemen having taken the LNT principals to heart, the organization nationwide has become very well respected by the various land managers. They listen to us when we voice our opinions. This is a good thing! It also doesn't hurt that we donate many hours of volunteer labor to their causes, which are our causes too.

iGive? What is iGive? iGive is a shopping web site that has many on-line stores, some of which I know your are familiar with. JCPenny, Macy's, Barn's and Noble booksellers, and on and on. Each store has a different percentage of “giveback” or donation.

You register with the iGive site (it's free) and you shop the stores by going through the iGive site. When you first register you are asked what organization you want to support (and you can support more than one but shop for only one at a time.) Once you place your order the donation amount gets calculated and once there is at least \$25 iGive cuts a check to us. You can make money even by searching and there is a link on the shopping page of the chapter web site.

To date (2/23/11) we have made \$75 and it will just continue to grow.
