#### Farm Plastics

Along with fresh produce, the use of plastic is growing on our local farmlands. More farmers are choosing to use plastic film instead of natural materials for agricultural operations. Until recently, farmers have had to treat these agricultural plastics as garbage; however, a pilot program by the Thurston Conservation District is providing free recycling to keep hay twine and straps, haylage wrappers, and woven polypropylene sacks (such as fertilizer, feed and seed bags) from ending up in a landfill. The pilot program is a joint effort with D&C Distributing out of Ellensburg.

Nearby recycling sites include:

Del's Feed & Farm Supply – Olympia (Old Highway 99)

Del's Feed & Farm Supply – Yelm (Highway 507)

Del's Feed & Farm Supply – Chehalis (Bins will be available soon at the Kresky Avenue store.)

Yelm Farm & Pet – Yelm (Bald Hills Road)

D&C Distributing picks up the plastics once a month. There is no charge for the bins or for pickup of the plastics. If you're interested in having a bin at your own location – either for personal use or as a service for others – please call the Thurston Conservation District at 360-754-3588.

Minutes approved.

Treasurer Report, Traci Koch – solvent. End of year bank statement just arrived.

Speaker Brian Stafki with Thurston County Solid Waste spoke on recycling – what can and cannot be recycled, and where can you take it (the twine on bales of hay can be recycled by taking it to Del's. Same goes for plastic feed bags. Give Del's a call and see what they'll take.) . He handed out shopping bags, brochures and refrigerator magnets.

Rendezvous is March 15-17 so register now. BCHW meeting, dinner, auction, dance, wine tasting, dutch oven cookoff, clinics and more.

Auction – what to donate. There was a motion to CONTINUE to donate a trail saw with scabbard (It's been costing about \$110). Approved.

Donate items for the auction – tax deductible as BCHW is a 501(c)(3).

Table decoration contest – chapter should think about doing it.

Newsletter/Web site – Chris Enrico

Chris said he's not yet fixed the members area but he did mail out the links to that information along with instructions to not delete the email. Chris said he's also been adding interactive maps like National Forest trail systems.

New Business –

Thank you to Rob Keyser for use of his barn for the Christmas party. Motion was made to give Rob cash (approved) and Dean Hartman will handle it.

Good of the order –

Jeff LaBreck said he still has some calendars for sale. The chapter will have sold 195 when Jeff sells what he has.

Traci Koch thanked chapter members for attending the New Years Day ride at Kennedy Creek as well as Chris Enrico for playing camp cook that day.

Attending chapter members at the Map and Compass class thanked Chris for putting the class on.

Carrie will provide treats for the February meeting. Carrie also got back from spending a month in Arizona so will share her story.

BCHW Board of Directors Meeting  
12/8/12  
Ellensburg, WA-Kittitas Valley Event Center

1. December calendar Grand Prize winner (\$3000) was Dallas Muir of Elma.
2. Treasurer's Report: Teri Starke: All chapters can pool their savings accounts into a BCHW Money Market account and get a higher interest rate. (Chapter accounts will be kept separated)
3. Public Lands Report: Jeff Chapman.
  - a. There were about 100 BCHW members present at the Public Lands meeting on 12/7/12. It was a very interesting and informative meeting.
  - b. BCHW Legislative Day is 1/28/13. It will begin with a meeting on the 3rd floor of the Capitol Building. A large tent will be set up near the fountain that will represent all WA ST recreation groups. BCHW Directors voted to spend \$200 to show the economic impact of equines to recreation.
  - c. The Gifford Pinchot NF is doing a road analysis to determine which roads will be earmarked for maintenance. They are asking for public input so BCHW members should respond by letting them know which camps/roads that we use. (An Action Alert has been sent regarding this.)
4. Ways and Means: Dave Swanberg reported that calendar sales were going well but 100 were left to sell. The remaining calendars were distributed to chapters.

BCHW Cook book: Volunteers have stepped up to put together a cook book and hope to have it ready in time for Rendezvous. If BCHW can sell 500 of them for \$15 each they could generate about \$5000 profit. BCHW members will be asked to submit recipes. A vote was taken and BCHW Directors passed a motion to go ahead with the Cook book project.
5. The BCHW State Ride (Ken Wilcox Ride) will be held 7/19-7/21/13 out of the Les Hilde trailhead.
6. The BCHW store has lots of new items. Place an order with a Director so they can save you shipping costs by picking up your order at a quarterly meeting.
7. Rendezvous: There are only 300 dinner tickets available for the live auction on Saturday. Preorder early!!      Camp- ing: Only dry camping is available at the Kittitas County Event Center. There is a free lot on      the north side of the grounds or other fee sites with/without electricity on the west side of the grounds. If you bring a dog you must be respon- sible to clean up after it. (There were complaints last year.)
8. Whistler Canyon Trailhead (Okanogan Chapter) is now complete and ready for camping, thanks to support from BCHW members!
9. Saw Certification: Training for certifiers will be in the spring in Eastern and Western WA.
10. Safety Education: Doc Wesselius feels a need for emergency evacuation education. He would like to have ideas for safety training.
11. LNT: Jane Byrum reported the \$7000 grant had been approved which paid for a number of BCHW projects that were accomplished last year. There is an additional \$30,000 lined up for future LNT programs. The Trailhead News will have a schedule of classes. The Randall class will be the first weekend of April. It's an excellent opportunity for persons who haven't been before.
12. BCHA Dues Increase: BCHW Directors passed the \$5.00 dues increase for BCHA membership.
13. Future Rendezvous dates at Kittitas Valley Event Center (KVEC) were discussed. Rendezvous will be held again in March of 2014. Other meeting dates for 2013 will be selected soon.

14. Dungeness National Wildlife Refuge: Jeff Chapman explained the serious hiker/horse accident that occurred at DNWR last summer. As a result, USDFW is proposing to close the area completely to horses. BCHW feels that more information is necessary to assess the situation and perhaps prevent the area from being closed to horseback riding. BCHW may be seeking legal advice regarding the USDFW action.
15. Wilcox Horse Camp (Haney Meadows) rebuild project: Jason Ridlon (Alpine Lakes Trail Riders chapter) is heading up a BCHW state work party to restore trails destroyed by the Table Mountain fire last summer. It is an opportunity for BCHW chapters to come together and help restore the beautiful, historic area. The USFS will need to make preliminary safety assessments in June and July before any work can be planned, so the work party most likely would be August or September. Chapter work party leaders need to contact Jason for project assignments.
16. Gravel Pack-In (Capitol Forest) 4/13/13: BCHW Board of Directors approved up to \$500 for user groups to purchase food for the event. Darrell Wallace will temporarily be the liaison for BCHW/DNR. He also needs a safety officer position to be filled.
17. Grant Committee: Judy Smith (Mt. St. Helens chapter) will replace Lori Lennox on the committee. Several chapters helped to improve the grant applications so that they can achieve better scores.
18. Review of the 2013 Budget: Requested by Dave Jackson (Purple Sage Riders chapter). Teri Starke distributed the 2013 budget for review by the BCHW BOD. The 2013 Budget was then approved.
19. Award Committee: Deb Wesselius, chair, asked for nominations to be completed and sent in to her by 2/15/13. Joann Yost was appointed to the Awards Committee.
20. Publicity: Chair Dick Yarboro asked that articles for the Trailhead News be submitted early. New BCHW brochures have been ordered. Directors can pick them up for chapters and save shipping costs.
21. Volunteer Hours: Deb Wesselius There will be training at Rendezvous for new Volunteer Hour Coordinators.

#### Good of the Order

1. Purple Sage Riders chapter director, Dave Jackson, presented BCHW with a \$1000 check earned from the Winery Ride. He will be presenting another \$1000 check to BCHA from the profits. Other chapters and volunteer groups that help to put on the Winery ride earn another 20% of the earnings while the chapter itself keeps @10%.
2. A tribute to Wenatchee Valley chapter Director, Carol Wilcox was made. She received a standing ovation for being on the BCHW Board of Directors for 17 years. She has always been a respected, active member along with her late husband, Ken Wilcox, for their work in founding BCHW and dedication to its mission.
3. Bill Ford, Methow Valley chapter Director, asked for support from BCHW members regarding the building of North Summit Horse Camp. (See the Nov/Dec Trailhead News) Please send a short comment of support for the horse camp to Bill Ford, PO Box 902, Twisp, WA. Or email him at WPJC.org@centurylink.com
4. Teri Starke, BCHW Treasurer, said there will be a Treasurer training class at Rendezvous. All chapter treasurers are requested to attend. Donations to BCHW (for Rendezvous or other) require filling out a Donation Form. The white copy goes to the donor, yellow copy to Teri, and pink copy to the chapter treasurer. This is for BCHW IRS purposes.




