Assuming you read this prior to June 1st, there is a work party scheduled for the day, National Trails Day, June 1st. Meet at Mima Falls Campground day use area. It is a 9 am start so bring your horse, loppers and trail saws. Work will be on the Mima Campground Trail up to the Mima Tie Trail (old


Trail #6 up to Trail #10). Be sure and bring Discover Pass, lunch, water, gloves, good boots and rain gear if the weather is suspect.

I'm sure that most of you have heard of the Interstate 5 bridge collapse over the Skagit River by now. The bridge is just shy of the SR 20 turn off heading to Les Hilde. The current plan is for a temporary structure to be complete in a few weeks (before the scheduled trip by the chapter.) There are detours in place but there are traffic backups. (so far as backups go, there is a 25 mile one extending from Ellensburg to Roslyn heading west on Interstate 90 this evening of 5/27. The first major music festival at the Gorge didn't help.)

Chris is adding interactive maps showing landowner boundaries. When it comes to weed free feed it's a good idea to know where you are. Indian Camp in the Teanaway is a good example in that it's on the edge of the DNR parcel and adjacent to USFS and private lands.

The JBLM link to training areas open or closed has been updated. Karen Johnson will send Chris the new link. Chris said it's hard to find the bad links. (since rectified as Chris found a program to do this).

Gravel Haul Liaison Karen Johnson

There were 101 people at the gravel haul with 55 BCHW members plus bikers and hikers. There were 27 stock, 7 of which came north from Oregon. It was wet but all participating had a good time. There were no safety issues. Pierce County Chapter provided lunch which was spaghetti with French bread.

National Trails Day

A motion was made and approved to give Joyce a pre-paid Visa card.

She sits in the back of the room, drinking a sip out of each one in turn. When she finishes them, she comes back to the bar and orders three more.


The bartender approaches and tells the cowgirl, "You know, a mug goes flat after I draw it. It would taste better if you bought one at a time."



