Please try to be early but the schedule tends to get a little behind toward the end of the day. Please bring a book or something for you to do while you wait.

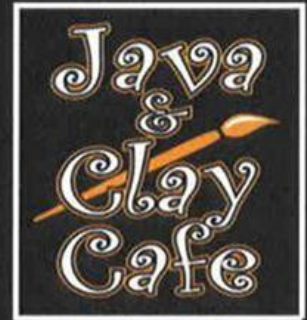
