**Do you have any 2015 calendars sold** yet? Karen brought some back from Ellensburg and will be passing them out at the meeting. They are not hard to sell at all. What you have to do is mention them to all you might come in contact with. For me the raffle ticket is a bigger part of the sale.

#### **September 2, 2014**

“A quorum to conduct chapter business requires fifty percent of the Board to be present, one of whom must be the President or Vice President.” – Chapter bylaws

Neither officer was present.

What follows are not official meeting minutes and any motions approved are invalid! (one concerning calendars)

17 in attendance with one guest – Bud Blake (running for county commissioner), and 2 honorary members and guest.

Karen Johnson told the group how much was in the chapter bank account (we are solvent) and that there is nothing outstanding.

Karen went on to mention that the BCHW member dues cutoff is January 1st.

She also mentioned the following so far as volunteer awards – A chapter or the state organization is not allowed to use money for gift certificates or cash awards.

Karen also said the Wine Ride still needs volunteers.

Chris Enrico mentioned the newsletter and web site. Someone (sorry didn't write it down) suggested including member spotlights in the newsletter.

As Peggy Ticker was not present, Karen asked that members keep track of their miles ridden and get them to Peggy by November 1st.

Deb Hall has a few people yet to get volunteer hours from.

Carrie Russell told the group that Dean Hartman had hurt his back and couldn't ride at Kalama for two days. Carrie also said “Don't miss the falls!”

She also said that there has been ONE chapter camp out so far this year. Carrie asks that members send her a list of at least two places they want to go to.

Vivian Eason told the group to start wearing brighter colors while riding (hunting season). She also suggested having a clinic with equestrians and bikers.

Sue Koch had a flyer for a clinic at the Scatter Creek arena. It's on 10/18-19. Chris will scan and post. (Sue subsequently sent Chris a PDF of the flyer which he distributed via email).

Karen will bring treats for the October meeting.

### **From the DNR User Group meeting: 9/11/14**

DNR is applying for grants soon. They need a \$21,000 in match from volunteers to fund 4 bridges on the non-motorized section. Our volunteer hours are rated at \$15/hour. We signed onto the grant applications which means we will help to support the construction of the bridges. The grant hearings will be sometime between 10/2 and 10/10 at the Natural Resource Building (1111 Washington Street SE, Olympia). The dates and times will be determined. You can attend to speak in support of one or more grants.

DNR personnel are currently working to install culverts to divert water away from the Lost Valley trail. The trail had some dangerous spots which are much better now! (Ride it while it's dry before the rains begin!)

There will be logging sometime this fall and winter near the D4000 road/Lost Valley. Be aware of truck traffic!

Event planning for next year will take place at the next User Group meeting November 13th, 6:00 PM. There will be no events scheduled prior to June 1 or on holiday weekends in 2015.

### **Legislative “stuff”**

There will be a BCHW lobby day and a Big Tent lobby day.

Recreation is vulnerable including grant funds while the Legislature tries to deal with education funding in light of the recent involvement of the Supreme Court.

There will also be in-depth discussions once again on private land fees/liability, Discover Pass/State Parks, and the other matters which have shown up over the last several sessions.

DNR has been holding meetings around the state (the DNR region we are in, South Puget Sound, had a meeting in Issaquah) to help decide trail policy. Our Director Karen Johnson and other BCHW members attended the one being held in Battle Ground (Pacific Cascade Region). Equestrians were well represented.

Congress passed a Continuing Resolution funding government at current levels until December 11th. This will mean that everything will continue to work until December 11th, being after the elections. RTP will get a part-year allocation. One of the bills that may likely come up when Congress resumes after the elections is a renewal of Payments In Lieu Of Taxes (PILT) and Secure Rural Schools (SRS), perhaps combined programs. These are important programs to Counties, to roads, and to the USFS.

The Washington Wildlife and Recreation Program (WWRP) grant list is out and BCHW has been reviewing it. Most all trail projects are rail trails around the state including the Spruce Railroad, Naches, Ferry County, Foothills and Willapa Hills trails. The Kalama Falls WDFW acquisition grant proposal for a riding area near Kalama horse camp rated at the bottom of its category again which once again means it may be out of reach.

Of the Natural Area projects, the Kennedy Creek Natural Area Preserve is second on the list in that category so it may get some money. *“The Department of Natural Resources will use this grant to purchase 80 acres. The project area will increase protection for one of the few remaining high-quality salt marsh communities in Puget Sound, including vital habitat for migrating shorebirds and salmon. It includes the protection of a segment of Schneider Creek which supports the health of the salt marsh ecosystems. The site is located off Highway 101 near the Mason-Thurston County line, approximately 12 miles west of Olympia. The priority parcels will add to the protection of high priority natural heritage features in the statewide system of natural areas by adding to the existing natural area. It will provide opportunities for education and research.”* As you can see this project will not impact the use of the trails upland of the marsh area.

Of interest to those of you in the south county, the State Lands Restoration and Enhancement Projects category has at the top of the list Grassland Restoration in South Puget Sound. *“Scatter Creek, Mima Mounds, Bald Hill, Rocky Prairie and West Rocky Prairie are home to rare plants, animals, and plant communities of remnant South Puget Sound grasslands and oak woodlands. They are of concern to Washington Department of Fish and Wildlife and Washington Department of Natural Resources in that they are degrading from pressures from invasive species. The WWRP project goal is to restore these rare habitats emphasizing needs for federal and state listed threatened and endangered plants and animals and WDFW’s Species of Greatest Conservation Need. This 2-year project will a) acquire native seeds and transplants, b) prepare areas for seeding (prescribed fire, herbicide), c) conduct seeding and plug planting, d) control exotic grasses and forbs, and e) conduct integrated Scot’s broom control. Other actions include oak release at three sites, and Oregon spotted frog habitat enhancement at West Rocky Prairie. WDFW, WADNR, Joint Base Lewis McChord, and the Center for Natural Land Management have built a partnership to provide a diversity of native species for direct seeding in grassland and oak woodland restoration in south Puget Sound. This is a cooperative project due to identical restoration needs, that saves time and money by avoiding redundancies in staffing, contracting, and seed source development.”*
